

# WAIVER FOR IN-PERSON APPOINTMENTS DURING COVID-19 OUTBREAK

Vantage Financial Partners Limited, Inc. is committed to doing its part to protect the health and safety of our clients, employees, and communities during the coronavirus (COVID-19) outbreak. To that end, we ask that, when possible, only essential parties attend and all attendees agree and sign to the following guidelines:

**On the day of the appointment.** we ask that everyone attending an in-person appointment complete this waiver.

1. Have you or anyone in your household had any cold or flu-like symptoms, such as fever, cough, or shortness of breath, within the last 14 days? Yes  No
2. Have you or anyone in your household been in contact with anyone diagnosed of having COVID-19 within the last 14 days? Yes  No
3. Do you believe you have any reason to believe that you may have been exposed to COVID-19 while you were traveling domestically, especially to/from high-risk States, current 'hot-spots' or internationally within the last 14 days? Yes  No

**At the appointment,** we ask that everyone use good hygiene and other preventative measures to prevent potential spread of germs. Please ring the doorbell outside the building door, enter and wait in the downstairs outer lobby. Your Relationship Manager will greet you and escort you to the meeting. Prior to the meeting all attendees will have their temperature taken. Should anyone be found to have a temperature, they and those accompanying them, will be unable to attend. Prior and at the meeting we further recommend you:

- Follow prevention and preparation guidelines as posted on the Centers for Disease Control and Prevention website (CDC.org).
- Please bring and wear a mask when indoors and when unable to meet the 6' social distancing requirement. Masks are required indoors at all times.
- Do not shake hands.
- We will provide a new pen to sign documents. Do not share pens.
- Wash your hands before & after the appointment with soap & water for at least 20 seconds, or use hand sanitizer.
- Avoid touching your eyes, nose, or mouth with unwashed hands.
- Avoid close contact. 6' social distance will be provided when possible.
- Should you discover you may or are infected within 14 days following your appointment, please contact your Relationship Manager immediately.
